# POST GRADUATE DIPLOMA IN MEDICAL RADIOLOGICAL SCIENCES (PGDMRS)

Medical physics is a profession that combines principles of physics and engineering with those of biology and medicine to provide better diagnosis and treatment of human disease while ensuring the safety of the public, patients and those caring for them.

#### **SCOPE:**

Most medical physicists are employed at universities and hospitals with a smaller number in research institutes, government health agencies, and industrial organizations. A few are self-employed, usually as consultants.

Frequently, the hospital in which a medical physicist works is associated with a medical school, and the physicist is a member of the academic staff. P.G.D.M.R.S. is a professional course at the Post Graduate level that prepares the students for clinical practice as a medical physicist. The P.G.D.M.R.S. program offers students course work and practical clinical training in Medical Radiological physics as it is applied to the diagnosis and treatment of human diseases. Required course work provides theoretical and practical training in radiation dosimetry, radiation biology, radiation therapy, imaging, and health physics. Graduates of this Post Graduate Medical Physics program typically go on to successful clinical and academic careers where they contribute to all specialty areas of medical physics.

#### **ELIGIBILITY CRITERIA**

M.Sc. Physics with minimum 60% of marks.

#### **NUMBER OF SEATS**

Eight (8)

#### **DURATION OF THE COURSE**

- Course work and practical: 12 months (First Year)
- Internship and Project and Dissertation: additional 12 months (Second Year)

#### **ADMISSION PROCEDURE**

Selection is based on the Marks obtained in the Entrance Examination, qualifying examination and personal interview conducted by the Department.

Amrita Institute of Medical Sciences, a constituent Unit of the AMRITA VISHWA VIDYAPEETHAM conducts PGDMRS in its Health Sciences Campus at Kochi, Kerala, India. Selection for PG Admissions is based on the rank obtained in the Amrita Entrance Exam 2022.

#### **PROXY REPORTING FOR ADMISSION**

Reporting for admission by proxy is not permitted. Admission of the allotted candidates who do not report to the Admission Office, Amrita School of Medicine, Kochi shall stand cancelled.

In extremely exceptional cases, where the candidate is unable to report physically due to illness for attending admission procedure, Chairman – Admissions at his sole discretion may permit candidate's father, mother to attend counselling on behalf of the candidate on the basis of a written request. Also specific authorization from the candidate with relevant Medical Certificate from a Medical Officer not below the rank of a Civil Surgeon or a Clinical Associate Professor of a Medical College should be submitted at the time of reporting for admission.

#### **Verification of Documents**

• All admissions / allotments are subject to verification of the original certificates and documents submitted by the candidates. The decision of the Chairman - Admissions regarding the eligibility of applicants shall be final.

- If at any time before or after admission it is found that the candidate does not meet the eligibility requirement, seat will be denied to him/her. Therefore, it is the sole responsibility of the candidates to ensure that he/she meets all the eligibility requirements.
- At the time of reporting for Admission to Amrita Institute of Medical Sciences, Kochi, candidates should be accompanied either by their parent or spouse and should produce the following documents / certificates in Original along with one set of photocopies. A document to prove the Date of Birth (SSLC or Birth Certificate)
- A document to prove the Date of Birth (SSLC or Birth Certificate)
- Plus Two Mark List
- Degree Certificate with mark list
- PG certificate
- Transfer Certificate & Character and Conduct Certificate from the Head of the Institution last studied
- Migration certificate
- Relieving letter / NOC from the previous employer, whichever is applicable
- Two copies of Aadhaar Card and PAN Card of the candidate
- Recent passport size close-up color photographs of face 6 nos
- Physically Handicapped Certificate (if applicable)
- Caste Certificate (if applicable)
- Medical Certificate for physical fitness and mental soundness from a medical officer (Government Hospital / Government Medical College) not below the rank of Civil Surgeon or a Clinical Associate Professor of a Medical College (as per the format prescribed in Amrita website)

- 2) CANDIDATES COMING FOR ADMISSIONS/COUNSELING/INTERVIEW WITH INCOMPLETE LIST OF THE ABOVE DOCUMENTS WILL NOT BE ALLOWED TO ATTEND THE ADMISSION PROCEDURE & WILL BE REJECTED)
