ORDER

WHEREAS, recognition was granted to the institution namely **Amrita Shikshana Mahavidyalaya, No. 114, 7<sup>th</sup> Cross, Bogadi 2<sup>nd</sup> Stage, Mysore-570006, Karnataka** run by **Amrita Shikshana Mahavidyalaya, Mysore, Karnataka** vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2004-2005/8832 dt. 30.011.2004 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, the **Amrita Shikshana Mahavidyalaya, Mysore, Karnataka** vide its letter dated 23.06.2007 requested for change in the name from **Amrita Shikshana Mahavidyalaya, Mysore, Karnataka** to **Amrita School of Education, Mysore**. The change of name was permitted in SRC's 138<sup>th</sup> meeting held on from 24<sup>th</sup> to 26<sup>th</sup> July, 2007 and the institution was informed vide letter dated 5.10.2007.

AND WHEREAS, the institution vide letter dated 28.11.2018 requested to update the name as Department of Education under Amrita Vishwa Vidyapeetham and issue an office order for the same.

AND WHEREAS, the SRC in its 370<sup>th</sup> meeting held on 07<sup>th</sup> -08<sup>th</sup> February, 2019 considered the matter and decided as under;

1. Two issues are involved:
  - (i) Change of Name.
  - (ii) Reply to RPRO.
- 2.1 From a school of Education they now want to become a Dept. of Education of an umbrella organization called Amrita Vishwa Vidhyapeetham.
- 2.2 This involves major changes in the management structure. There are some restrictions on such changes. We will need to examine registration of Society details, title to properties, etc. Ask them to give.
3. They have not responded to our RPRO at all.
4. Issue SCN accordingly for rejection.

AND WHEREAS, as per the decision of SRC, a show cause notice was issued to the institution on 15.02.2019. The institution has submitted notice reply on 2.3.2019, 5.3.2019, 12.3.2019, 13.06.2019 & 21.06.2019.

AND WHEREAS, the matter was finally considered by the SRC in its 379<sup>th</sup> meeting held from 21<sup>st</sup> & 22<sup>nd</sup> August 2019 decided as under:-



The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

- (i) In view of the request made by the Amrita Vishwa Vidyapeetham University and in view of the order issued by the MHRD vide notification dated 10<sup>th</sup> November, 2006 and also perusing other documents the SRC agreed to change of the name of the Institution as Amrita School of Education under the Amrita Vishwa Vidyapeetham University.
- (ii) Further on the perusal of the original documents and records made available in the file, the Committee decided that the **continuation order be issued** to Amrita School of Education, Amrita Vishwa Vidyapeetham University No. 114, 7<sup>th</sup> Cross, Bogadi 2<sup>nd</sup> Stage, Mysure – 570026 Karnataka for B.Ed programme for 1 unit of 50 students.

**NOW THEREFORE**, this order is issued permitting the institution change of the name of the Institution as **Amrita School of Education under the Amrita Vishwa Vidyapeetham University**. Further the institution **Amrita School of Education, Amrita Vishwa Vidyapeetham University, Sy. No.114, 7<sup>th</sup> Cross, Bogadi II Stage, Ward No. 22, Mysore City Corporation, Karnataka-570026** is also permitted for continuation of conducting B.Ed course of two years duration with an intake of 50 students (one basic units) subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation form the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
6. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
7. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
8. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-
- a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.



- c. Name of faculty members who left or joined during the last, quarter;
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students;
  - f. Available infrastructural facilities;
  - g. Facilities added during the last quarter;
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information, if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
10. The institution shall make available the list of students admitted on its official website.
11. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
