TRAINING PROGRAMME FOR PROBATION OFFICERS AND LEGAL CUM PROBATION OFFICERS TO STRENGTHEN CHILD PROTECTION SERVICES IN TAMIL NADU- NORTH ZONE

The Department of Social Work at Amrita Vishwa Vidyapeetham, Coimbatore in collaboration with Department of Social Defence organized a Two- day Training Programme for Probation Officers and Legal Cum Probation Officers to strengthen child protection services in Tamil Nadu- North Zone on 7th and 8th November 2023.

DAY 1 (07. 11. 2023)

Mr. M. Saravanakumar, Regional Probation officer, Department of Social defence presided over the first session. It was on the Mandates for Probation Officers and Legal cum Probation Officers under the Juvenile Justice system and the duties and responsibilities of the probation officers and legal cum probation officers.

Mr Saket Shegoonkar, Manager- State Training and quality Assurance, Miracle foundation, India handled the second session on Social Investigation Report, Alternative forms of care and gatekeeping. Mr Benin from Miracle foundation had an interactive session with the PO and LPO's about the child care institutions. He also discussed about the status of the children globally, post institutional syndrome, the status of the children in India and in Tamil Nadu. Concepts like family strengthening, Individual Care Plan, Social Investigation Report and Case Management process were also discussed in the session.

DAY 2 (08. 11. 2023)

The morning session was on demonstration of the intake process of the Social Investigation Report led by Mr. A. Alfred David- Chief Probation Officer and Mr. M. Saravanakumar- Regional Probation Officer. The officers engaged in a simulated intake process, obtaining insights and information from a social work student acting as children in conflict with the law. The demonstration aimed to illustrate the procedures involved in creating Social Investigation Reports, offering valuable practical experience for the participating officers in understanding the complexities of such investigations.

The subsequent session was a group activity with each group tasked to present their respective case studies. The Regional Probation Officer (RPO) and Chief Probation Officer (CPO) provided valuable insights and feedback on the presented case studies. This engagement allowed for an exchange of perspectives, where the RPO and CPO shared their expertise and offered guidance based on their experience and knowledge in the field. The collaborative approach enabled a comprehensive review and discussion of the case studies, fostering a rich learning environment for all participants

At the afternoon session, Dr B. Selvaraj- Head, Department of Psychology, Government Arts college, Coimbatore. He explained about the effects of positive reinforcement in enabling good behaviour in child and spoke about the two techniques to avoid Juvenile delinquency which are shaping and modelling.

The two-day event covered a wide range of topics related to child welfare, legal aspects, and social work practices, ensuring that the participants would be better prepared to safeguard the well-being of children in Tamil Nadu. It was a good learning for both the officers and the students participated in the programme.

Kannur Squad is an amazing craft done by director Roby Varghese Raj. It is a movie about a police officer and his team face a challenging journey across the country to catch a criminal gang. SISTERS UNDER THE RISING SUN BY HEATHER MORRIS

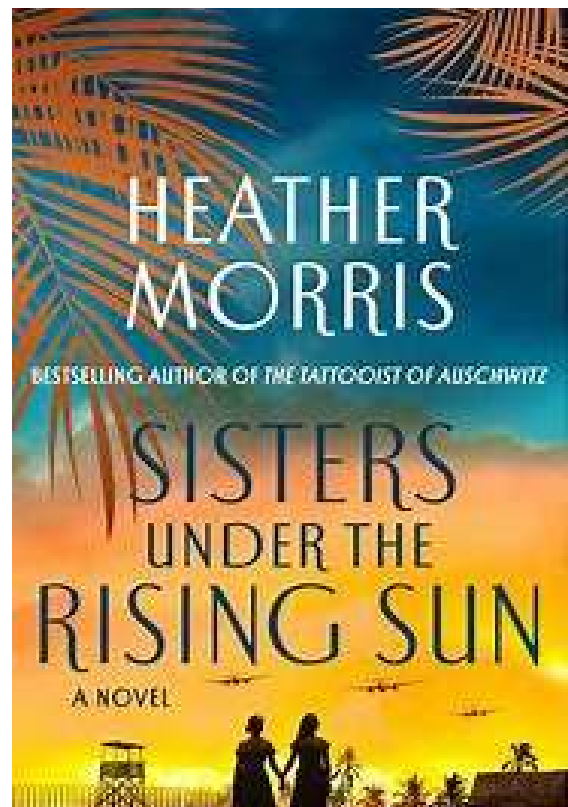
Heather Morris' *Sisters Under the Rising Sun*. For Ms. Morris, this is her fourth book. She writes historical novels with amazing talent and excellence. The narrative is based on a real-life incident. The Vyner Brook Tragedy is the subject of this. Merchant vessel Vyner Brook. The Japanese Air Force struck the ship and sank it while it was transporting refugees from Singapore. Japanese soldiers eventually caught the sinking survivors after they swam to a distant island.

Desperate to keep her safe as the island falls to the Japanese Army, English pianist Norah Chambers, then eight years old, puts her daughter Sally aboard a ship departing Singapore during World War II.

Nesta James, an Australian nurse, has volunteered to care for Allied soldiers. However, she finds herself trapped in the Vyner Brooke trade ship with the terrified passengers, including the heart-broken Norah, as Japanese troops invade the island. Two days later, off the coast of Indonesia, they are attacked from the air, and the Vyner Brooke sinks in a couple of hours. Nesta and Norah make it to the shores of a distant island after surviving a full day at sea, only to be taken prisoner and interned in one of the infamous Japanese POW camps. The camps are locations of extreme cruelty, malnutrition, and widespread illness. However, happiness can still be found here thanks to music, as Norah's "voice orchestra" can carry the internees from the darkness into the light. Norah and Nesta, who are sisters in arms, dedicate their lives to ensuring the women's survival while also realizing their own remarkable capacities for bravery, love, and strength.

The writing is fluid and colorful. The characters are brave, tenacious, and trustworthy. Additionally, the plot tells a powerful story of love, friendship, sisterhood, survival, tragedy, self-discovery, heartache, determination, hope, and the brutalities of war. Rich, complex, and enduring characters make up the cast. Even more tragic is the realization that these are based on actual people's lives as you read. It was amazing how dependent the "sisters" were on one another and the other inmates. Every event, disease, penalty, and movement convey to the reader the horror of how cruel people can be to one another.

I read *Sisters Under the Rising Sun* cover to cover because it is an engrossing, deep, and emotional story. I adore Heather Morris's writing, and this book lived up to my expectations. I heartily suggest it if you want well-researched WWII novels from a novel and distinctive viewpoint.

SCHEMES AND ACTS



ACTS

THE LIMITED LIABILITY PARTNERSHIP ACT, 2008

In April 2021, the government introduced the Tribunals Reforms (Rationalisation and Conditions of Service) Ordinance, which was later replaced by the Tribunals Reforms Act, 2021. This law eliminates some appellate tribunals and transfers their functions to existing judicial bodies like high courts. It also abolishes specific tribunals, such as the Film Certification Appellate Tribunal and Airports Appellate Tribunal, while altering the terms of service for tribunal officials. The Supreme Court questioned the government about quickly passing the bill and requested reasons for its introduction.

SALIENT FEATURES OF THE ACT

- Committees, known as Search-cum-Selection Committees, will be formed to recommend individuals for the positions of chairpersons and members in tribunals. The Central Government will then appoint these individuals based on the committee's suggestions, aiming to act on the recommendations within three months.
- The committees' composition includes the Chief Justice of India or a Supreme Court judge nominated by the Chief Justice as the Chairperson, two government-nominated secretaries, a current or outgoing tribunal chairperson or a retired Supreme Court judge or Chief Justice of a High Court, and others. Similar committees will be established for State administrative tribunals, with members such as the Chief Justice of the state's High Court, Chief Secretary of the State Government, and others.
- The Act stipulates a four-year tenure for members, with a minimum age requirement of fifty for the Chairperson. The tenure for members is either four years or until they reach the age of 67, whichever comes earlier. In the case of chairpersons, the tenure is either four years or until they reach the age of 70, whichever comes earlier.
- In 2017, the Finance Act merged tribunals by their areas of expertise and granted the central government authority to establish rules for search-cum-selection committees, qualifications of tribunal members, and terms of service, including salary and removal. The recent tribunal reforms act eliminates these provisions from the Finance Act.

CENTRAL VIGILANCE COMMISSION INTERNSHIP SCHEME 2016

The Internship Scheme initiated by the Central Vigilance Commission in 2016 is a strategic endeavour to involve Indian nationals, encompassing graduates awaiting final year results, postgraduates, and research students enrolled in prestigious universities or institutions, both within India and abroad. This program, with a focus on disciplines such as law, IT, MBA, social sciences, and related subjects, seeks to provide interns with a comprehensive understanding of the Commission's operations and vigilance-related issues. The interns play a crucial role in supplementing the Commission's analytical processes by actively engaging in the empirical collection and collation of in-house and external information. Through their contributions, interns are pivotal in shaping policy formulation and generating empirical analysis, briefing reports, and policy papers. This symbiotic relationship benefits both parties - interns gain valuable exposure to the Commission's functioning, enhancing their career goals in diverse sectors or international organizations, while the Commission gains access to additional resources and young talent, enriching its policy formulation capabilities.

The internship duration spans a minimum of one month, extendable to two months, typically occurring between May and August. Before commencing their assignments, interns are required to submit a Declaration of Secrecy, emphasizing the confidential nature of their work. In acknowledgment of their efforts, interns may receive a stipend of ₹10,000 per month, aimed at covering conveyance and daily expenses. This financial support ensures that interns can actively participate in the Commission's initiatives, fostering a dynamic learning environment. Ultimately, the Internship Scheme emerges as a dynamic platform fostering collaboration, knowledge exchange, and the development of a future cadre well-versed in vigilance issues, policy formulation, and the intricacies of administrative functioning within the Central Vigilance Commission.

UNEMPLOYED YOUTH EMPLOYMENT GENERATION PROGRAMME

The Government of Tamil Nadu has a program called “Unemployed Youth Employment Generation Programme (UYEGP)” through its Micro, Small and Medium Enterprises Department. This program helps unemployed young people, especially those from socially and economically disadvantaged backgrounds, to start their own businesses. They can get loans of up to ₹15 Lakhs for manufacturing, ₹5 Lakhs for services, and ₹5 Lakhs for businesses. The government provides a subsidy of up to 25% of the project cost, with a maximum limit of ₹2.50 Lakhs. The goal is to support marginalized youths in becoming entrepreneurs.

Benefits

The State Government will give financial help, called subsidy assistance, for up to 25% of the project cost (with a maximum limit of ₹2.50 Lakhs) to help people start manufacturing, service, or business enterprises under this scheme.

Eligibility

- To be eligible for the scheme, the applicant must be a permanent resident of Tamil Nadu, at least 18 years old, and no older than 35 (for the General category) or 45 (for Special categories).
- They should have passed 8th standard, with a family income not exceeding ₹5 lakhs per year.
- General category applicants contribute 10% of the project cost, while Special category contributes 5%.
- Entrepreneurship Development Program {EDP} training is required.
- Project costs should be within ₹15 lakhs for manufacturing and ₹5 lakhs for Trading/Service projects.

1. WHITE LUNG SYNDROME OUTBREAK

On December 2, 2023, a concerning global outbreak of 'White Lung Syndrome,' a new strain of bacterial pneumonia, emerged, primarily affecting children aged three to eight and manifesting as visible lung damage with white patches on X-rays. The syndrome encompasses various respiratory conditions, including Acute Respiratory Distress Syndrome (ARDS), Pulmonary Alveolar Microlithiasis (PAM), and Silicosis, presenting common symptoms such as shortness of breath, coughing, chest pain, fever, and fatigue. Investigations into potential causes suggest a combination of bacterial, viral, and environmental factors, including influenza, COVID-19, *Mycoplasma pneumoniae*, and exposure to silica dust. Treatment options, tailored to the specific cause, range from antibiotics, antivirals, and oxygen therapy to mechanical ventilation and corticosteroids. The severity of the disease dictates the chosen approach, with outcomes varying from full recovery to potential long-term lung damage.

2. FIRST WOMAN DIRECTOR GENERAL OF ICFRE

In a significant milestone, Kanchan Devi, a 1991-batch Indian Forest Service Officer from the Madhya Pradesh cadre, has made history by becoming the first woman to be appointed as the Director General (DG) of the Indian Council of Forestry Research Education (ICFRE), a prestigious position under the Union Ministry of Environment, Forest, and Climate Change. Headquartered in Dehradun, ICFRE plays a crucial role in advising the Government of India, state governments, and various stakeholders on forestry research and technologies, addressing emerging challenges in forest conservation. With over 30 years of diverse experience in forestry, Kanchan has excelled in forest management, administration, education, human resource development, research, and extension. As a faculty member at the Indira Gandhi National Forest Academy (IGNFA), Dehradun, she contributed significantly to forestry education. During her tenure as Deputy Director at ICFRE, Kanchan played a pivotal role in promoting forestry education, accrediting courses, conducting research studies on forest policies, and advancing human resource development. Her notable contributions include establishing the Centre of Excellence on Sustainable Land Management (CoE-SLM) and implementing the World Bank-funded

Ecosystem Services Improvement Project (ESIP) at ICFRE. Additionally, she has been instrumental in recruiting and promoting scientists and technical officers within the council, further solidifying her impactful career in forestry.

3. HISTORIC MILESTONE: NEPAL OFFICIALLY REGISTERS FIRST SAME-SEX MARRIAGE

Five months after Nepal's Supreme Court groundbreaking decision legalizing same-sex marriage, the country has officially registered its inaugural case, solidifying its position as the first South Asian nation to recognize and formalize such unions. The historic event unfolded in the Dordi Rural Municipality of Lamjung district, Western Nepal, adding a local touch to the broader narrative of progress. This legal triumph not only reflects a shift in Nepal's legal landscape towards inclusivity but also symbolizes a cultural and societal embrace of diverse relationships. Against the backdrop of Western Nepal's rich heritage, the formal registration of the first same-sex marriage in Lamjung becomes a significant milestone, resonating as a beacon of hope and inspiration for LGBTQ+ communities across the region. Nepal's pioneering stance sets a precedent for its neighbours, urging them to reconsider and advance towards more inclusive legal frameworks, making this achievement a multifaceted testament to progress that transcends both legal and cultural dimensions.

4. ILO REPORT HIGHLIGHTS DEADLY CONSEQUENCES OF OVERWORKING WORLDWIDE

A sobering revelation emerges from a recent report by the International Labor Organization (ILO), shedding light on the dire consequences of overworking that claim the lives of nearly three million individuals each year across the globe. This alarming statistic underscores a shifting paradigm where employment, once a source of livelihood, now emerges as a major contributor to mortality. The study particularly emphasizes the disproportionate impact on men, signalling a critical need for revaluation of work-related practices and policies to mitigate the tragic toll of excessive labour on human lives. As we grapple with these findings, it becomes imperative for societies and policymakers to prioritize the well-being of workers and foster a balanced approach to employment that safeguards both livelihoods and lives.

5. WORLD'S 1ST TRANSATLANTIC FLIGHT USING 100% GREEN FUELS TAKES OFF

Virgin Atlantic's Flight100, a historic transatlantic journey powered by 100% Sustainable Aviation Fuel (SAF), demonstrates SAF's viability for long-haul flights, with a unique blend of 88% HEFA and 12% SAK. Notable passengers include Richard Branson and CEO Shai Weiss. The Boeing 787, fuelled with 50 tonnes of SAF, aims to reduce aviation's carbon footprint. Collaborative efforts involve Rolls-Royce, Boeing, BP, and academic institutions. Imperial and Sheffield researchers will assess environmental impacts. While hailed as progress, some caution against "greenwashing," emphasizing the need to reduce flights and fossil fuel reliance. Flight100 precedes COP28 climate talks, sparking discussions on aviation's sustainable transition and challenges in scaling up SAF production.

6. UNVEILING THE MYSTERY OF STEVE: NOT YOUR AVERAGE AURORA

The recent mesmerizing displays of green and purple lights in the northern skies have unveiled an intriguing atmospheric phenomenon known as STEVE, or Strong Thermal Emission Velocity Enhancement. Initially, these vibrant ribbons of light were commonly mistaken for traditional auroras, but their distinctive nature sets them apart. STEVE is characterized by its unique features, including its narrow structure and location further south than typical auroras. Scientists are actively studying this phenomenon to better understand its origin and the underlying atmospheric processes that contribute to its striking visual effects. As nature once again surprises us with this ethereal spectacle, researchers and enthusiasts alike are delving deeper into the mysteries of STEVE, adding a new layer of fascination to our understanding of Earth's atmospheric phenomena.

7. CONTINUATION OF FAST TRACK SPECIAL COURTS

Prime Minister Shri Narendra Modi, leading the Union Cabinet, has given the nod for extending the Fast Track Special Courts (FTSCs) as a Centrally Sponsored Scheme (CSS) from April 1, 2023, to March 31, 2026. This move, backed by a financial commitment of Rs. 1952.23 crore, underscores the government's steadfast dedication to accelerating trials concerning sexual offenses, a crucial step in safeguarding the well-being of women and children and ensuring their safety and security.

8. CABINET APPROVAL FOR PRADHAN MANTRI JANJATI ADIVASI NYAYA MAHA ABHIYAN (PM JANMAN)

The Union Cabinet, led by Prime Minister Shri Narendra Modi, approved the Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PM JANMAN), allocating Rs.24,104 crore for tribal welfare. PM JANMAN aims to enhance the socio-economic conditions of Particularly Vulnerable Tribal Groups (PVTGs) with a Rs.15,000 crore budget for the next three years. The initiative focuses on 11 critical interventions across nine Ministries, addressing basic needs like housing, water, sanitation, education, health, and livelihood opportunities. The Ministry of Ayush and the Ministry of Skill Development and Entrepreneurship will contribute by establishing wellness centres, extending medical facilities, and providing skill training in PVTG habitations. The mission recognizes the vulnerability of PVTGs despite their cultural richness, with the 2011 census recording a Scheduled Tribe population of 10.45 crore in India.

9. INDIA REQUIRES \$101 BILLION INVESTMENT TO ACHIEVE TRIPLED RENEWABLE ENERGY TARGETS: REPORT

India needs \$101 billion more in investment to triple its renewable energy capacity and meet the International Energy Agency's Net Zero target by 2030, according to a report by the energy think tank Ember. The report outlines that between 2023 and 2030, India requires a total investment of \$293 billion to achieve its solar and wind capacity targets, including storage and transmission. To align with the IEA's Net Zero goal, India must increase annual additions to 41 GW of solar and 11.8 GW of wind by 2027, requiring an additional 115 GW of solar and 9 GW of wind by 2030. The report estimates that meeting these targets will result in a total renewable capacity of 448 GW of solar and 122 GW of wind by 2030. Crucial to this effort is the establishment of a grid that integrates renewables, requiring increased storage and transmission capacity, including 48 GW of interstate transmission systems (ISTS) and at least 14 GW (six hours) of battery storage. Despite increased investment, challenges such as payment delays, Power Purchase Agreement renegotiations, and land acquisition complexities pose risks. With India securing a G20 commitment in

September 2023 to triple global renewable energy capacity, there is anticipation to secure a global commitment at the 28th Conference of Parties (COP28) to the United Nations Framework Convention on Climate Change. Attracting foreign investment is crucial for successful implementation, and addressing risk factors is pivotal in securing financing for India's renewable energy projects.

10. ASSAM GOVERNMENT, NDDDB SIGN MOU FOR THE HOLISTIC DEVELOPMENT OF DAIRY SECTOR

The Assam government has partnered with the National Dairy Development Board (NDDDB) to enhance dairy farming in rural areas. They aim to increase daily milk production in the state from the current 29 lakh litres to a target of 39 lakh litres. The plan includes setting up six mega milk processing plants to make Assam self-sufficient in both milk and egg production. The government has identified land for these plants and aims to organize the unorganized 95 percent of the state's milk production. This collaboration builds on a historic agreement signed in January last year, envisioning Rs 2,000-crore joint venture for comprehensive dairy sector development over seven years.
